

## **LEGAL BASES**

### **Paddock passes raffle – Japanese GP**

#### 1. ORGANIZING COMPANY AND OBJECT

Bamboleo Events S.L.U. (hereinafter, “Bamboleo”), with NIF B-44565257 and registered office at Rambla Lluís Sanpere, 1, 25200 Cervera, LÉRIDA, organizes an action giveaway among all WE ARE 93 members who attend the WE ARE 93 Tribune for the 2023 Japan GP [hereinafter, the "Action"]. The Action aims to give 3 double paddock passes to attend the paddock zone at the JapaneseGP held from the 29<sup>th</sup> of September to 1<sup>st</sup> of October.

#### 2. TERRITORIAL AND PERSONAL SCOPE

The Action will take place in any geographical area, and all individuals who are members of the WE ARE 93 community and has a ticket for the V2 Marc Marquez Seat at the Mobility Resort Motegi. Not all people professionally related to the Action or the organizing company may participate. Participation from missing emails or different profiles belonging to the same person is prohibited. In the event of detecting any irregularity, both in the participation and in the identification data of the participants and in the content sent, Bamboleo reserves the right to disqualify the participant in question.

#### 3. TEMPORARY SCOPE

The Action will be effective on September 18<sup>th</sup>, 2023 and will end on September 21<sup>th</sup>, 2023 at 12:00hpm Spanish time.

#### 4. DESCRIPTION OF THE ACTION

To participate in the Action people must fill up the form published at the WE ARE 93 website <https://weare93.com/>, be an active WE ARE 93 community member and have a ticket to the V2 Marc Marquez Seat, at the JapaneseGP.

Mechanics of action:

The action is planned as a raffle among those who send fill out the form and fulfill the previously explained options within the commented dates.

#### 5. PRIZE

The Action will have 6 prizes: 3 double paddock passes to go at the 2023 Japanese Grand Prix. The attendants must have to be WE ARE 93 members.

All details about the event will be announced to the winners once the raffle has been made. They do not cover the travel and the accommodation. Once the raffle for the passes has been made and the schedule for the exclusive tours has been awarded, no changes can be made.

#### 6. WINNERS

WE ARE 93 will announce the winner on 21/09/2023 on the WE ARE 93 website and on an Instagram story. The winner will be chosen from among the participants who are registered within the selected days. The prize will be awarded by lottery, which will be held through an automatic random selection program. The winner / s will be contacted via email and must respond to it within twenty-four (2) hours from the announcement of the winner, accepting the

prize. If the winner does not respond within the established period, their candidacy will be declared void.

#### 7. DELIVERY OF THE PRIZE

The awarding of the award will be physically. The passes will be nominative and must be picked up by the Circuit Accreditation center individually.

#### 8. ACCEPTANCE OF THE RULES

By participating in this Action, the participant expressly agrees to comply with each one of the conditions established in these Terms and Conditions. For reasoned reasons, Bamboleo may modify these rules once the action has begun. Bamboleo will be exempt from any obligation or compensation with the participants, if due to force majeure or legal imperative the present Action should be canceled or suspended, a situation that would be conveniently made known to the participants.

#### 9. INTELLECTUAL PROPERTY

The winner of the prize indicated in these rules authorize Bamboleo, without territorial or temporal limits, to reproduce, disseminate and use by any means, in any form and on any medium, their name and surname and image, for marketing purposes, promotion and publicity, such use may include publication on Bamboleo websites (both internal and external), including social media pages and internal communication platforms such as Bamboleo intranet.

#### 10. PROTECTION OF PERSONAL DATA

Bamboleo will not use personal data for any purpose that is incompatible with the purposes listed below, unless required or authorized by law or authorized by the participant to do so. The Bamboleo will process personal data for the following purposes: to be able to contact the participants to be able to deliver the corresponding prize and add it to the Database for sending newsletters with the sole purpose of informing about Marc Márquez or the WE ARE 93 community. The legal basis for the processing of personal data is the implicit consent granted by the participant through their participation in the Action. #### 12. RESPONSIBILITIES
